5.3.3 Inspection Schedule for Open Line Officials:

The schedule of inspection of open line officials for Track Machines shall be as hereunder:

Officials	Type of Inspection	Schedule
Sr. DEN/DEN	Track Machines: (i) CSM, BCM, FRM(SBCM), P&C Tammer, DTS, 09-3X Tamping Express (ii) T-28, PQRS, RGM, TRT (iii) Worksite Tampers (UT/UNO/ DUO/WST etc), BRM, Sleeper Exchanger, UTV and all other machines not included above.	Once in two months when working in section. At least once in a month. As per need.
ADEN	Track Machines: (i) CSM, BCM, FRM(SBCM), P&C Tammer, DTS, 09-3X Tamping Express (ii) T-28, PQRS, RGM, TRT (iii) Worksite Tampers (UT/UNO/ DUO/WST etc), BRM, Sleeper Exchanger, UTV and all other machines not included above.	Once in a month when working in section. At least once in a fortnight. At least once in a period of working in their section.
SE (P. Way)	Inspection of pre-tamping, during tamping and post tamping operations during working of track machines	Once at the time of tamping.
JE (P.Way)	Inspection of pre-tamping, during tamping and post tamping operations during working of track machines	Once at the time of pre- tamping, during tamping and post tamping.

The Sr. DEN/DEN and ADEN shall inspect the track machines as per above schedule, duly covering all aspects i.e., adequacy of all allied track works, quality of machine work, safety aspects involved, items pertaining to the welfare of machine staff, records such as programme of tamping, actual tamping, variations, repeated tamping, speed restriction etc.

Copy of inspection report of Sr. DEN/DEN and ADEN shall also be sent to Deputy Chief Engineer/Machines.
